In 2017 he testified before Canada's Parliament on the enforcement of economic sanctions and anti-terrorism laws, and many of his recommendations were adopted in the House of Commons 2017 report: A Coherent and Effective Approach to Canada's Sanctions Regimes: Sergei Magnitsky and Beyond. John is the organizer and course leader of Lexpert's annual full-day Canada-wide Anti-Bribery and Corruption Course, currently in its sixth year.

A prolific author and sought-after speaker, John received his B. Comm. (Gold Medalist) from the University of Toronto in 1990.
